- Bylaws and Board of Directors to be posted on website.
- 3 year term commitment for Executive Board.
- Recruitment for Board Members
 - Develop a recruitment letter.
 - 7 positions are open.
 - Reach out to HOAs.

New Business

- Urban Forestry Associates proposes that Fire Safe San Mateo develop a membership program to target landscapers, gardeners, landscape architects, pesticide applicators, tree services, and similar related businesses that operate in San Mateo County.
 - Program might charge an annual fee in exchange for training and listing on the Fire Safe San Mateo website and publications.

- Might be modeled after the California Oak Mortality Task Force membership and training program.
- Fire Safe San Mateo should be careful not to use language such as "certification" to describe any potential training or seminar provided to members. Certification is a loaded term with implied responsibility.
- UFA has identified nearly 400 potential businesses in industries related to fuels management and wildfire hazard reduction in San Mateo County.
- Training might include Defensible Space creation, fire safe landscape practices and building, recognizing structural vulnerability.
- Denise Enea recommends moving forward to develop a more detailed proposal, and wants FSSM to focus additional resources on education.
- Philippe Cohen suggests finding a collaborating organization, and emphasizes that any training provided must be credible.
- Dick Schwind discussed the possibility of expanding a program like this to trrain volunteer educators, who could then bring the FSSM message and defensible space education to homeowners.
- Some discussion regarding potential liability issues.
- Denise Enea requests that UFA begin moving forward.

Grant Proposals 2013

Margaret Glomstad, Director of Parks and Recreation for the City of Burlingame provided a written proposal for grant funding in Wildland Urban Interface Areas (see attachment).

- Project is located in Mills Canyon.
- 18 acre park, would utilize hand crews to create a 30' shaded fuel break extending two miles around the park.
- Project may be considered maintenance, which might reduce cost associated with CEQA.
- Work with Friends of Mills Canyon.
- Burlingame Fire and Parks might provide chippers.

Ed Cooney from the Town of Hillsborough provided a written request for grant funding for several projects in the Town, including (see attachment):

- Public outreach campaign.
- Fire mitigation and maintenance equipment.
- GIS Mapping.
- Fire road maintenance.
- Ongoing maintenance of Defensible Space Zones and high fire risk areas.

Clayton Jolly, CAL FIRE update on coastal projects requiring grant funding.

• Coral Reef project needs maintenance.

- Cooperative, using crews.
- may use Federal dollars if available.
- 3-5 days of work are needed.
- Last maintenance was 4 years ago.
- Global grant for San Mateo County Eucalyptus removal.

Andy Hubbs, CAL FIRE.

- CAL FIRE fuel removal funding typically came from Federal Fuels dollars. This source of funding will end in 2013.
- SRA fee may help fund future fuels projects.

2013 Goals:

Fire Safe San Mateo will establish simple, attainable goals for projects and progress in 2013.

- 1. Increase General Membership representation.
 - Outreach and recruitment to HOAs and business community.
- 2. Apply for grants.
 - Develop a list of potential projects.
- 3. Complete transition to 501 c(3).
- 4. Update "Living With Fire."
 - Form committee.
 - Inventory current stock.
 - Email group asking for inventory and needs.
- 5. Develop a membership training program per UFA proposal.

Additions to Agenda:

Books and Finances.

- Request accounting report from County, even if format is difficult to read.
- Account balance was \$162,000 at last report.
- \$15,000 is owed to Ben Lomond Camp.
- UFA has sent bill for services.
- Invoices in past came from Steve Richmond, payable to San Mateo County Fire Department.
- San Francisco Water want to continue paying SMC fire, since paying to a sole source is easier than paying to a council.

Living With Fire Update:

- Need to assess the need for updates and number of copies currently available, and required in 2013.
- Evaluate for potential updates:
- Code changes may be introduced July 1, 2013.
- Look for code language references and evaluate for potential update.
- UFA can manage updates to the electronic version in any pre-press format. Request an electronic copy from the printer.
- Christine Reed will contact the FPOs by email to ask if they use Living With Fire, and evaluate need for additional copies.

Urban Forestry Associates Update:

- Bookkeeping
 - FSSMC will open bank accounts and create a budget after non-profit status is approved.
 - Camp billing needs review.
 - Steve Richmond will request a bookkeeping report from the county, but warns that they are difficult to read and understand.
- UFA will establish a Google Apps account under the FSSMC domain name to improve communication, document sharing, and collaboration.
- UFA will undertake the advancement of the FSSMC website.
 - New website will be presented at January meeting.
 - Previous website developer had discarded site due to inactivity, so UFA is starting from scratch.

Grant Applications:

- Members are encouraged to contact Urban Forestry Associates with ideas for projects that may benefit from grant funding.
- Per Denise Enea and Andy hubbs, the CA FSC grant for the chipping program was declined, but there is no word yet on the WUI grant.
- Per Rich Sampson, the CWPP will be updated soon. We are looking for RCD funding again. This time look for buy-in from Fire Chiefs, but not the Board of Supervisors.

Agency Roundtable:

Midpeninsula Regional Open Space District - Brian Malone

- Recently completed a 950 acre land purchase.
 - An old ranch, tours are available to FSSM members if requested.
 - Will be managed as a grazing property.
- Highway 35 CDC work is complete.
 - Billing is paid and finalized.
- Mulder Trail is now complete.

South Skyline Fire Safe Council - Dick Schwind

- 25 CDC sponsors have been trained.
- RCD and WUI grants include 1500 hours of volunteer time to-date.
- Acquired a new tool a sled for moving brush uphill.

San Mateo County Fire - Andy Hubbs

- WUI Grant was rejected.
 - Failed to fund chipping program in 2013.
 - Will look into reason grant was rejected.
 - \$100,000 was awarded in 2011.
